





#### **"Ojai Valley News Publishes Pro-Develop**ment Agenda" Advert: Make Ojai 'Better'

• Does Ojai need the added traffic congestion that will be brought here by overdevelopment and an expensive new performing arts center?

• Does Ojai need a new taxpayersubsidized performing arts center to compete with, and possibly ruin, cherished establishments like the Ojai Art Center and Theater 150 ? · Does Ojai need a taxpayer-subsidized performing arts center to

draw patrons and funding away

from the *Libbey Bowl* and recently remodeled Matilija Auditorium ? It is doubtful that whoever is

behind the Make Ojai Better survey paid for an entire page in the Ojai Valley News just to ask if we need to support local artists. The survey questions suggest a progrowth, pro-developer agenda, and are formulated to elicit only positive responses to issues that some wrongly believe will be solved by turning the Ojai Valley into a miniature San Fernando Valley.

Don't be surprised if Make Ojai Better announces that their survey reveals Ojai residents are clamoring for more high-density housing projects and a big expensive performing arts center; implying that we don't really care about increased traffic congestion, air pollution, diminishing water resources, the degradation of our small town quality of life or wasting tax dollars.

The survey is a crude example of a push poll, designed to advocate or push a political or social agenda rather the objectively sample public opinion. Even if Make Ojai *Better* intends to accurately report survey results, anyone who wants to send multiple, anonymous online computer responses or buys a few dozen newspapers, can easily distort the results.

A far more credible assessment of the values and priorities held by Ojai Valley residents has already been made by the *Ojai Valleywide* Discussion Project organized by Supervisor Steve Bennett in 2007. It involved over two hundred people in a series of open meetings where voting was openly counted and the agenda was not controlled by any single special interest group. The 4 top concerns were: preserving the environment and making Ojai a green community, disaster preparation, improved communication during emergencies, traffic congestion and improved public transportation.

Neither high-density affordable housing projects, nor a performing arts center were even listed among the top 13 concerns of valley residents.

#### **Utility Companies Still Drowning Ventura County Ranchers**

he past few years have been very difficult years for the Southern California citrus industry. Thousands of orange acres have been removed from production due to seriously depressed crop returns. Some production areas within the county have relatively limited choices of alternative crops for a variety of geophysical reasons....Ojai being a case in point. The struggle to remain in agriculture, and necessarily maintain a profitable economic position, will be made extremely difficult or impossible by the imposition of water rates that so markedly increase what is already grower's single biggest expense.

Interestingly, and I think significantly, the Casitas dam water project was initially proposed to provide support for the local ag industry in drought times, and as such received a loan from the Bureau of reclamation interest-free to the extent that agriculture was expected to be the user of the water. How ironic if in the end Casitas water rate hikes spell the demise of the Ojai citrus industry.

## Whose Cable is it Anyway ?

jai's Channel 10 will be ending as of Jan. 1, 2009. At that time, channel 10 will be handed over to the *City of Ojai* and no longer run by *Time Warner*. There will be no Public Access programs, nor any of the Government meetings aired on Channel 10.

The way it works now, *Time Warner* has an employee that comes to the Ojai studio three afternoons and evenings a week. Monday and Tuesday's are for Public Access/Educational programs and Wednesday is just for the Government programming.

When Channel 10 is handed to the City of Ojai it will then be Ojai's responsibility to either eliminate the channel altogether, or continue running the channel themselves. The City of Ojai is considering using the internet by having streaming video of the City *Council* meetings but what about all of the seniors in Ojai that do not have a computer or don't know how to use one? They are the ones that like to watch the meetings on television. I myself prefer to have the television on instead of watching a tiny little 320 X 240 video on my computer.

It would be nice if we can continue the programming on Channel 10. There are people that are adamant that the Government programming is mandated. Well, that is just not true. *The Digital* Infrastructure and Competition Act (DIVCA) of 2006, AB 2987, permits cable companies to franchise with the state of California instead of with the individual cities as they have in the past. This eliminates the responsibility of the cable company of operating a local public access studio in the future. The original Federal Communications Commission (FCC) ruling provided for Public Access, Educational and Government (PEG), channels. Here in Ojai this has all been done on Channel 10. DIVCA does not mandate that PEG continues, but it does eliminate the opportunity for each community to decide if they want it and then

it would have to be a part of the franchise agreement.

On Dec. 20, 2006, the FCC gutted their funding to continue with their PEG rulings which provided for the PEG/Community Media throughout the country. The Digital Infrastructure Video *Competition Act (DIVCA)*, which took effect Jan. 1, 2008, places the Public Utilities Commission (PUC) in charge of choosing which cable company each community will be using as of Jan. 1, 2009. If the individual communities do not have a franchise agreement with a specific company, then the State of California PUC will make the decision as to which cable company will be used. If *Time Warner* continues as the cable company of Ojai, then there will be no PEG or Channel 10 unless the City of Ojai finds someone to run the station, or, they would have to run it themselves. Time Warner is shelving all PEG as of Jan. 1, 2009, unless their franchise agreement doesn't expire before then. There are other options if the City of Ojai is interested. The cable companies pay each city 1% of the money they collect from the cable fees for their community. Shouldn't this 1% be used to continue Channel 10? When we had the *Ojai Ranch Fire* in 1999, how did we learn what was happening and the status of the fire? Channel 10.

When we had the *Wolf Fire*, how did we find out the status of it? Channel 10.

When we had the flooding a few years ago and the roads in and out of the Ojai Valley were impassable, how did we find out what to do? Channel 10.

If Channel 10 is shelved then what do we do in a disaster ?

## Who's Watching The Store Over At Ventura City Hall...? **By Frank Pecarich**

few weeks ago after saying they believed they only had a minor problem with revenue this year, the City of Ventura came out with a revised position which said the City budget was in crisis. Well, they put it a bit differently in their March 19th press release with this euphemistic title, "City of Ventura **Executes Immediate Steps to Pre**serve Fiscal Sustainability."

With all due deference to the recent popularity of the term 'sustainability', after reading the press release I prefer my description of the situation as a 'crisis'. I know that if I had this much jeopardy in my household budget, I'd call it a crisis.

As far back as 6 months ago, there were cities in California that were indicating deep concern about their budgets given the State's economic problems. Last Fall, Alan Tandy, Bakersfield City *Manager* for example, publicly alerted their city council that there could easily be a major revenue shortfall. More recently, the *City* of Vallejo announced severe conditions that could lead even to *City* of Vallejo bankruptcy. The City of San Francisco has for months now been planning their major cutbacks to accommodate their shrinking revenue. Through all this and up to its March 19th announcement, the only problem identified by Ventura was a small shortfall of approximately \$2 million, which is not even a 2% shortfall in their overall budget.

On March 19th however, the City of Ventura jolted Ventura citizens to life with the announcement that cuts would likely need to be made and quickly. The list of probable cuts is extensive, including closing

*City Hall* every other Friday and an immediate hiring freeze. At least I thought, the City has finally caught on to the economic downturn by stating, "Locally, the economic downturn has affected City revenue through a loss of expected sales tax dollars - currently 10% below projections; decreased property tax from falling home prices - down 24 percent over the prior year; and a decrease in revenue from building permits - down more than 15 percent from expected totals."

Then the next sentence in the press release jumped out at me, City "liquidity has also been affected; the City holds \$10 million in what were AAA rated Bear Stearns investment notes". \$10 million of the City's assets were "invested" in *Bear Stearns (BS)* private assets which had been technically reduced to almost worthless in the JP Morgan buyout of nearbankrupt BS. What the City means is that their 'investment' is illiquid because it cannot be exchanged on the market for any amount of money close to the initial investment. That is to say, it is near worthless as long as it has no liquidity value.

Stepping back, we need to see there is a very special role that needs to be played with City assets by their Finance Officer and Finance Office. Paramount in any city finance mission is preserving the safety of the reserves and minimizing risk. If you review charters from municipalities all over the country, you will see that preserving financial assets is supposed to

be their top priority; any investment for gain should be done with the primary goal of asset preservation in mind.

City finance officers are supposed to be trained in public finance and have competence to determine the financial safety and viability of any investment proposal. Most cities invest their cash assets in highly safe Treasury instruments and other governmentbacked securities. Risking money with an investment bank such as Bear Stearns would not be high on a list of prudent investments. Pure investment banks such as Bear *Stearns* are not remotely similar to commercial banks such as Wells Fargo or Bank of America. There is no form of government insurance for deposits, and they are recognized as focused on higher risk ventures such as hedge funds, etc.

Bear Stearns was also heavily exposed to subprime mortgages, plus the firm had less capital and was less diversified than even its investment bank rivals. Moreover it should have been no big surprise to anyone paying attention that **Bear** Stearns was in trouble. As early as nine months ago, evidence of their trauma was in the news. (See sidebar, below - Bear Sterns, The Evidence of a High Risk Gone **Bad**) It can never be said that BS's problems were flying below the radar.

**Bear Sterns: The Evidence** of a High Risk Gone Bad ack in June 22, 2007 as reported by the *New York* Times and other mainstream press, Bear Stearns pledged a collateralized loan of up to \$3.2 billion to "bail out" one of its funds, the Bear Stearns High-Grade Structured Credit Fund, while negotiating with other

banks to loan money against col-

lateral to another fund, the Bear Stearns High-Grade Structured Credit Enhanced Leveraged *Fund.* The funds were invested in thinly traded collateralized debt obligations (CDO's) found to be worth less than their mark-tomodel value. Merrill Lynch seized \$850 million worth of the underlying collateral but only was able to auction \$100 million of them. The incident sparked concern of contagion as *Bear Stearns* may be forced to liquidate its CDOs, prompting a mark-down of similar assets in other portfolios.

During the week of July 16, 2007, Bear Stearns publicly disclosed that the two subprime hedge funds had lost nearly all of their value amid a rapid decline in the market for subprime mortgages.

Last July the financial stewards at the City of Ventura should have been taking actions that would have put Ventura at less risk. There is no good reason I can think of why Ventura is still holding **Bear Stearns** bonds which are presently worthless and which could have been sold on the market months earlier when Bear Stearns was clearly in so much financial trouble.

So we have two questions for the people charged with protecting our financial assets at the *City of* Ventura.

--Why did you even think about investing money in high-risk investment bank debt obligations? -- And, once it was clear there was a big problem with Bear Sterns, why did you not take action to avert the potential for a disastrous loss of needed reserve funds?

The stated investment policy for Ventura identifies "safety" of principal as the foremost objective of the City investment program. And

Ventura's Risky Business... yet with evidence mounting in the investment world for the past year that risk was high and ever increasing, the stewards of our financial assets did not act to lessen risk and the elected officials to whom they report did not intervene.

The City is supposed to have an oversight and advisory committee which is to help guide the City in investment matters. But when we look at the membership of this group called the "Investment Oversight Committee", we find it is comprised not of outside, independent financial advisors who could provide real advice and oversight. Rather it is composed of City Manager Rick Cole and three of his finance department employees and only one non-employee member, Rosa Lee Measures.

Checking the public record shows that Ms. Measures in addition to performing on the Ventura City Council in past years has made a career in banking over 25 years, serving as Vice President

and Regional Manager of the Imperial Savings and Loan Associa tion.

Call me naïve, but where was the representation of someone who is steepe in the financia practices of modern day public investment? Where is the

evidence that anyone


familiar with the daily topsy turvy atmosphere of fixed income investment was even available for consultation?

In other words and with all due respect for Ventura's pride in selfmanagement, who was watching the store?

How could anyone having any sense of the investment world not realize until sometime in March 2008 that major financial institutions all over the globe were crumpling like a cheap suit?

I would say that either the people responsible for money management in the City of Ventura didn't know what was happening or that they knew what was happening and chose to ignore the consequences. In any event, Ventura citizens deserve better and should demand better from their public servants and those who choose to lead them in elected office.

One of the items they are going to perpetrate on us lowly ignorant citizens is to have the Gang in the Ivory Tower meet only 3



By the way, are they still going to loan the Arts Council a couple of Million dollars to help in their construction of the Arts Colony ? R. Ellis Smith, Ventura





Bowl A rebuild was pitched by Bury and, if successful, would result in Ojai's historic Libbey Bowl being

completely torn down and subsequently rebuilt. "It is going to be razed. It is going to be 100% new", said Bury. Bury also said the project would be completed by the 2010 **Ojai Music Festival** season. The council has sidelined the normal process of process of

soliciting independent bids for the rebuild and has instead hired architect David Bury for the study. Bury was also mayor of Ojai in the late 90s. Ojai City Attorney Monte Widders clarified "

you recognize that you are in fact setting aside what may be the normal selection process and designating David Bury and associates.

The city did emphasize the need for community input. "The people that live in this city... any kind of funding, or grants that you may go after, or private money... really depend on the local citizens buying into the project. I can't emphasize... even getting the public involved, the city will do its part...", said city council member **Carol Smith**.

Steve Olsen noted the city council role in the Libbey Bowl development.

"It's gonna be a good sales job, I think on your part, to explain what you've explained to us tonight," Olsen said.

It is unclear the extent or scope of Bury's experience in organizing qualified sound consulting professionals and relevant contractors for an outside music venue. However, Bury is currently remodeling the theater at Ventura college. The significance of this Ojai Libbey Bowl project can't be underestimated, said the council. If a final building plan is ultimately approved by the city council, Bury said project costs to do a proper remodel could and should run upwards and past 3.5 million.

#### INTERVIEW: FRED VOGLER

red Vogler, is independent consultant, sound designer and lead mixer at the Hollywood Bowl. He resolved significant sound problems for the \$383.5 million Disney Concert Hall completed in 2003. The indoor Disney hall is considered one off the most acoustically sophisticated concert halls in the world.

Vogler, was the sound engineer for the Ojai Music Festival under Pierre Boulez, 1996, and is familiar with the acoustic issues of Libbey Bowl. Vogler worked on the recent rebuild of the Hollywood Bowl, completed in 2004, which cost \$18 million.

"I participated with the group of consultants for the new Hollywood Bowl sound system", said Vogler.

he Hollywood Bowl was upgraded for multiple reasons: the structure couldn't support modern concerts for large scale performances. They needed a structure that would support the lighting and amplifica-tion rigs for today's concerts, sound systems and for today's large scale touring performers. The **Hollywood Bowl** shell was made of asbestos, it was falling apart so there was no way to save it. I am familiar with the Ojai Bowl. I worked for the Ojai Festival about 10-years-ago when Pierre Boulez was conducting. The Hollywood Bowl and the Ojai Libbey Bowl faced many of the same issues, being outdoor venues with a lot of histori-cal significance. Both bowls were being challenged with the technology of today and with the amount of interface technology with live performance for classical, jazz, world music and pop... The line of what's electronic and what's acoustic (supporting acoustic music), is be-ing blurred more and more and that's for every type of ensemble including traditional ensembles. Of course, I do Rock n' Roll, too. The Libby shell, I know, is pretty small and it can't support the weight of the bigger ampli-fication systems. Because of the historic significance of the **Hollywood Bowl**, like **Libbey Bowl**, a lot of people were worried about rebuilding that. The architect should take into account the expectations and aesthetically match the needs of the client. The architect for the **Hollywood** 

Hollywood Bowl now just looks like a more upscale and modern Hollywood Bowl. The New Shell is at least 40 percent bigger and now we can host the big touring acts. It's been a big success; it's a fantastic venue. They actually razed it and knocked the entire thing down, dug a big hole and built a whole new structure. There are a lot more amenities than there ever were. Now we can host the big rock shows like the **Rolling Stones.** The big touring acts these days have lots of lighting, lots of video... The Hollywood Bowl is by far the best ever: we have used the same sound system for the Rolling Stones, the LA Philharmonic, The Who, Rod Stewart, Simon and Garfunkle, to name a few. These acts all use the same sound system, with different equalizations and different level amounts. It's the most transparent and yet full-

sounding system that has ever been there. If the **Ojai City Council** is really serious about rebuild-ing the **Libbey Bowl**, they have to start by consulting with people in the **L.A. Philharmonic**... or people within the industry who can provide a skill level and experience... There's only about half a dozen across the United States who are qualified. They absolutely need to hire a sound designer and an acoustician. I think it's crazy to go into designing a venue without getting advice from these people. The architect doesn't have to know sound, but they need to bring in a team of sound engineers who can advise them.

I have colleagues who have banded together to consult for that purpose. There's a lot of incompetence out there... you need to get a good sound engineer on board and a good acoustician and the city will not only save a lot of money, but avoid costly mistakes. You want someone who's had a lot of experience with live sound. There's certain needs that are specific to live concerts. In a live show there's no stopping and going back and fixing it. All these moving parts have to be choreographed so that's there's not chaos but there's a fantastic show. At the end of the day, you have to connect that performer with the audience and all the technology has to get out of the way of that connection.... It's a tough gig. It requires making decisions on the fly and having the tools at hand to deal with what can happen. It usually takes about 10 to 15 years of dealing with this to get a pretty solid perspective.... There are plenty of really talented people who do it and there's plenty of incompetence too. People refer to Ojai as kind of an upscale artistic com-

munity, so there's a really high expectation level for Ojai to produce quality. It has to be done right. You don't want some schlocky distorted amplification system. The Walt Disney Concert Hall was designed by architect Frank Gehry who has an ability to bring together a great team

Right now, I'm doing another project with them, Michael Tilson Thomas and the World Symphony.

#### INTERVIEW: KATHE LENSKI

athleen Lenski is the first violinist and founding  $\mathbf{N}$ member of the Los Angeles String Quartet. Ms. Lenski appeared as soloist with the Los Angeles Philharmonic, the Seattle, San Fransisco and St. Louis Symphonies, as well as touring and recording with the **Baroque Ensemble**, "Musical Offering". She served as soloist and Concert Master of the Los Angeles Chamber Orchestra, and was soloist and leader of the Oregan Back Festival Chamber Orchestra. Other festival ap pearances Aspen, Marlboro, Sitka, Cape and Islands, and the Accademia Chigianan in Sienna, Italy. Kathleen has also performed on soundtracks for hundreds of films including E.T., Schindler's List, and all of the Disney animated features.



One of the major problems at **Lib-bey Bowl** is that the exposure of the instruments to the elements does not produce the best quality of sound from the orchestra. When I soloed at Libbey Bowl in the late 60s, I clearly remember the difficulties we went through tuning our instruments. Changes in humidity cause the wood and strings to swell and shrink which immediately changes the tuning, and on string instruments this has a huge effect on sound production. My

violin is a **Gaudagnini**, which was made in Turin, Italy in 1775 belonged to a close friend of **Johannes Brahms**. Many of my colleagues play very old instruments which can be valued at up to \$300,000 or more. When exposed to humid conditions, such as performing at the **Tanglewood Festival** outside of Boston, some of these old instruments have literally come apart. In extremely dry conditions, I have to place a small damp sponge inside of my violin to try to provide stable humidity. These in-struments were not meant to be played outdoors so I try to avoid effects on my violin. In the more modern venues the humidity is usually controlled in the dressing rooms so that the musicians can move from the dressing rooms to the stage without exposing their instruments to the elements. In 2004, I played with the Los Angeles Chamber Orchestra in the "new" Hollywood Bowl which is now quite good since they have done so much to improve it. They now have a great sound system and the outer lip of the shell comes way out so that the orchestra sits deep within the shell and is protected from exposure to the elements. The **Ojai Music Festival** is now a nationally known festival. Everyone loves the rustic atmosphere of the **Libbey Bowl**: it's great being in a park and hearing wonderful music.

#### **Incredible Species**

All of the incredible species of wildlife on our planet Earth are defenseless without our support. This is the time to establish policies on a small personal scale as well as on a broad public scale to protect and maintain planetary health.

#### **Keeping Our Coasts Clean**

Dear Friend: Too many of America's coastal communities have been im-pacted by oil spills. These spills have both environmental and economic consequences. I have been working to reduce the number of incidences and the consequences of spills, and I am pleased to let you know that I recently joined in introducing legislation to modernize and make safer ships that carry fuel. The **Oil Spill Prevention Act of 2008, S.2699**, would

require double hulls on bunker fuel tanks on non-tank vessels, strengthen the Coast Guard medical review process for licens-

ing pilots and merchant mariners, direct the Coast Guard to make improvements to its vessel tracking system to prevent navigational errors and accidents, and phase out federal liability limits for oil spills from single-hull tanker ships.

In light of the devastation caused by the Exxon Valdez spill in Alaska in 1989, the recent spill in the Bay Area caused by the Cosco Busan, and countless other spills, it is time that ships be modernized and other changes be made to ensure that our coasts are not violated by oil spills. This legislation is a step in the right direction, and I will be working with my Senate colleagues to enact it.

ack in the 90s Jeff did a series of articles on a local developer who transgressed all

"Peter, this is an important issue for me, I'm of Italian-American descent myself. I've researched every minute detail, the article stands as written...period!"


Not only did he not apologize or rescind, he continued to report on this issue and the developer's alleged mob connections.

Whenever he would talk about them, which was often, love would beam through his eyes. I've known Ana and Rosa since they were little girls. They are truly beautiful souls, which is a compliment to Jeff and their mother, Catherine.

I first met Jeff shortly after I moved to Ojai. In the early eighties, my brother and I would hike the local trails. In the evening we'd hit The Hub, listen to good music on their jukebox, hoist a few brews and then head down to the jail in Libbey

Park to crash in our sleeping bags. I first fell in love with Ojai when I woke up one morning with the sun rising and took in the soulful vibe of Libbey

Park. Many of the people I know fell in love with Ojai, that's why they moved here.

Ten years later I arrived to put down roots. During my second week I attended the music festival with a bottle of wine in my

cooler. I believe the symphony was from Johann Sebastian Bach or Ludwig van Beethoven. At that time, my musical leanings were towards Rock, Bluegrass, Folk and the Blues. This was my first attendance in a symphony. The music was awesome, transcending and

absolutely beautiful. When the music stopped, I got up, applauded whooped, hollered and screamed "Bravo! Bravo! Bravvvooo! I was the only one. All of a sudden people around me hissed, "Psst,

I will draw on your warrior spirit who fought relentlessly and uncompromisingly for freedom of speech and freedom of the press, a gift given to us in The Constitution by our forefathers. 


















hose of us who were involved in the birth and development of The VOICE with Jeffrey San Marchi shared his ideals and passionate desire to see a free press exist in this town and other towns across the nation in order to uphold the individual's First Amendment rights, as defined in the United States Constitution, drafted September 17, 1787.

Jeff was keenly aware of the insidious loss of personal freedoms, which have been eroding over the course of 221 years. The keystone of democratic government is separation of powers as laid down by founders in the U.S. Constitution, ie: neither the legislative, executive nor judicial branch was ever to have an unfair advantage over the others.

It is said that the fourth leg of our system became the press, which empowers the citizenry. Its primary obligation to question governmental authority was clearly ensured by the framers of the highest law in the land, The First Amendment, in the Bill of Rights in 1789.

First Amendment -- "Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances."

In modern times, corporations have undue influence on individuals and grass roots groups (our founding fathers were a "grass roots" group) through ownership of the press and other media.

There are now very few solid free press publications that are autonomous or individually owned. Instead, most are owned and controlled by remote corporate interests, and run for profit. Most often the press has now become the wolf in sheep's clothing. For instance, the Ojai Valley News is not locally owned, but owned by a Tuscaloosa, Alabama based corporation and has thus, by definition, lost local autonomy.

## **20 Incontrovertible Truths about Global Warming** A Comprehensive Look at a Global Challenge

#### by Alasdair Coyne - Part I of II

he story of global warming is a complicated one. A proper understanding of it requires considering the long-term repercussions of how we are altering the life-sustaining ecological balance of the Earth. Scientists are saying that we must stop the current annual increase in global emissions of climate changing gases in as little as seven years from now. Meanwhile, life around us goes on as usual - people driving, flying and shopping, all of which contribute to climate change. There's

little indication that the necessary changes will happen in the next seven years. In the following article, I've outlined twenty points which should be useful

as you learn more about global warming. Future articles will focus on some of these points in detail.

Politicians often simply don't know how to respond to climate change. There are some champions out there, but most elected officials haven't taken the time to grasp the importance of the changes to our planet's life support systems that we are causing by our fossil fuel powered lifestyles. Nor do they understand that ignoring the issue is guaranteed to make those coming changes even more severe and permanent.

One important approach is grassroots education. Millions of Americans must absorb enough information about global warming that they begin to reevaluate their priorities, make appropriate changes in their own lives, and demand far-reaching and comprehensive political responses.

People must understand that the web of life that supports them with their food, water and shelter is undergoing such dynamic changes that these things will actually become less available to their children. The lifestyle of the

developed world, heavily based on fossil fuels, is not the only way to live on this planet. Climate change requires us to reinvent how we provide the energy for humanity's basic

needs – in the next seven years. It's time to start shouting from the rooftops. (1) GLOBAL WARMING IS CAUSED BY A BUILD-UP OF MINOR GASES IN THE ATMOSPHERE THAT RETAIN HEAT FROM THE SUN VERY EFFECTIVELY

Global warming gases are produced mainly by the burning of fossil fuels, the engines of modern industrial society. They are also produced by cattle and by deforestation, among other things. The predominant greenhouse gas is carbon dioxide, CO2. Nitrogen and oxygen, the major gases in our atmosphere, do not retain heat.

The buildup of these minor gases in our atmosphere has led to a warming of both the air and the oceans. This warming has disrupted what had been a relatively stable climate over recent centuries, and our continued reliance on fossil fuels is guaranteed to increase climate instability over decades, even centuries to come. Carbon dioxide in the atmosphere can remain there for up to 500 years.

Some results of climate instability are rising oceans, melting glaciers, shrinking ice caps over Greenland and parts of Antarctica, fiercer hurricanes, shifting rainfall patterns and long term droughts, and the extinction of a large percentage of plant and animal species, those that cannot adjust to the speedy rise in temperatures in their home environment.

(2) GLOBAL WARMING HAS COME ABOUT LARGELY AS A RESULT OF OUR IN-CREASED AND WIDESPREAD USE OF CHEAP OIL AND GAS SINCE THE END OF WWII The late 1940s saw the start of the great expansion of oil production from the Middle East,

which still holds the world's largest remaining oil reserves.

This flow of oil was cheaply enough extracted and marketed to allow for the manufacture and distribution of the plethora of consumer goods now enjoyed by the world's wealthier peoples. Advertisers joined in to create needs these people didn't know existed and which we now take for granted. In a nutshell, this is how we've got to where we are today, with fossil fuel usage at such a heightened level that it's changing our stable climate. Our modern industrial civilization depends even more on a stable climate than on the fossil fuels that it is currently addicted to.

(3) MOST PEOPLE IN THE RICHER COUNTRIES ARE RESPONSIBLE FOR TONS OF CARBON DIOXIDE RELEASED ANNUALLY INTO THE ATMOSPHERE



There's a little chemistry lesson needed here. When the carbon in fossil fuels burns, it reacts with oxygen in the air to create carbon dioxide, CO<sub>2</sub>.

Oxygen in our atmosphere is in itself not a greenhouse gas that absorbs heat. But when fossil fuels burn, each carbon atom joins up with two oxygen atoms to form CO2, multiplying the weight of the resulting greenhouse gas far beyond the weight of the carbon that was burned in the fossil fuel.

That's how using a gallon of gas in your car releases 20 pounds of carbon dioxide into the sphere. 100 gallons of gas release a whole ton of carbon dioxide; and filling up with 10 gallons of gas a week gives you a "carbon footprint" of 5 tons a year for your car, or around the US average. Add to that the electricity you use at home, and the furnace and

air conditioning, and the energy taken to transport the food and other stuff you buy from their origins to the stores you bought them all at, and the average American's greenhouse gas releases total about 20 tons a year.

#### (4) TO REDUCE CLIMATE INSTABILITY, WE MUST SPEEDILY REDUCE OUR GLOBAL CONSUMPTION OF **FOSSIL FUELS**

The International Panel on Climate Change (IPCC) reports to the UN with its findings. The IPCC is a consensus organization, which means that all its reports are approved by all of the 2,000 scientists from 100 countries that sit on the panel.

The IPCC's best estimates of how to slow global warming recommend that the developed world reduce its reliance on fossil fuels by the year 2050 by a factor of 80%, based on what was consumed in 1990.

So far, eighteen years into this sixty-year timespan, global consumption of fossil fuels is still rising – and rising pretty fast. We are not yet at the peak of fossil fuel usage, let alone returning to 1990s levels, let alone reducing that level by 80%. You could say that this is the bad news

California, which if it were its own country would have the world's sixth largest economy, has recently taken a lead in planning to reduce its greenhouse gas emissions. Legislation passed in 2006 requires the state to cut its carbon dioxide emissions by 25% between 2006 and 2020.

(5) PEAK OIL AND GLOBAL WARMING ARE BOTH COMING TO A HEAD AT THE SAME POINT IN OUR HISTORY

Oil is the overwhelmingly dominant fuel choice for global transportation by land, air or sea. Experts who study how much oil is still available to be extracted are in broad agreement that our global ability to produce oil will start to shrink within the next few years. The phrase "peak oil" refers to the time at which the volume of oil production begins a permanent decline. At the same time, demand for oil will still be rising, especially in fast-developing nations such as India and China.

This can only lead to one thing - steep, permanent and ongoing increases in oil prices. The same is true for natural gas, the cleanest fossil fuel in terms of climate change. Coal, the dirtiest fossil fuel in terms of climate change, is plentifully available.

Items such as plastics and fertilizers, which are made from oil and gas, will also go up in price. Just as we need drastically to be reducing the use of oil and gas to limit climate change, their prices will be going up. We will have to use less of them because we won't be able to afford to buy as much of them as we do now.

We must focus on two things that will help us address both problems - climate change and more expensive fossil fuels - namely, the use of alternative, renewable fuels and the greater application of efficiency to how we use fuels of all sorts. If you can perform a task - heating your house, or driving to work - with half the energy you use now, then you're still getting the job done, but you're only using half the energy you used before. That's what efficiency is all about.

(6) THE USA REMAINS THE KEY TO RESPONDING TO GLOBAL CLIMATE CHANGE We are, taken together, the energy hogs of the planet. With around 5% of the world's population, the US is responsible for a quarter of the world's greenhouse gas emissions. You might be surprised to learn that the US still has 30% of the 700 million cars in the world today - and that these cars produce half of the greenhouse gases of all cars everywhere. That's because our cars get worse mileage, and because we drive them further than do drivers elsewhere.

The US also is home to one in six power plants worldwide.

Quite apart from that, US media broadcast the American way of life across the planet on TV screens and at the movies. The whole world, just about, gets glimpses of the lifestyles of the rich and famous here in the USA, and as people in other countries get wealthier, they generally seek the large house, the cars, and the electronic gadgets that they've seen on those TV shows.

Which makes it doubly important for Americans to turn away promptly from the culture of consumption and the culture of affluence, and to demonstrate leadership in addressing climate change.

If we retain our current energy-intensive lifestyle (which doesn't produce the promise of happiness that it is sold to us with), there won't be much incentive for the fast-growing middle classes in India and China to aim for anything less. And the planet simply can't support another billion people living the resource-consumptive lifestyles that we "enjoy" here in the US

It's about time for TV shows and movies to reflect the reality of the era of human development that is now upon us – the dawning of the conservation society, where natural resources, including energy, are used sparingly rather than inefficiently and frivolously. This will be the message, and our way of life, for the indefinite future, like it or not.

By the way, Europeans enjoy a lifestyle comparable to that in the US, while using only half the electric consumption of Americans, mainly due to their smaller houses and appliances. Currently, the US is second last of around 56 developed nations in its response to climate change. Leaders in this tally include Germany, Sweden – and Mexico.

(7) THE MARKETPLACE IS NOT SETUP TO ADDRESS CLIMATE CHANGE ON ITS OWN Big business is geared to the short-term quarterly reporting of profits. On the other hand, a wide-ranging response to global climate change requires many avenues of planning and action over multiple decades.

**British Petroleum**, recently advertising itself as "beyond petroleum," is boosting its extraction of oil from coal tar sands, which will actually increase global warming because the processing is so energy-intensive.

And agriculture and energy interests are working to turn more and more of the US corn crop into ethanol, which is inefficient because of the energy already used by the fertilizers and farm equipment to grow the corn. What's more, a global shortage of corn has already resulted in widespread hunger, even food riots, in poor countries. "Done wrong, ethanol could wreak havoc on the environment while increasing greenhouse gases," editorialized the *New York Times* on Feb. 24, 2008.

Of course, the nuclear industry is pushing hard for new nuclear power plants. But these are so costly – and inevitably plagued by large cost overruns and decades of construction time – that available funding needs to be focused instead on efficiency programs, which make a large difference in very little time.

Now there are big businesses that are taking climate change seriously and that are making radical changes towards carbon neutrality (which means emitting no greenhouse gases, when a business' entire operations are considered as a whole). Google recently pledged millions of dollars for a project that will produce enough renewable energy to power all of San Francisco at a price cheaper than coal.

However, the momentum of big business is not yet positioned or ready to take the steps required to reduce greenhouse gas emissions globally. This is where legislative direction is vital, as well as consumer pressure.

Then there are the climate change denial corporations, chiefly **Exxon-Mobil**, who have spent millions of dollars over many years, to sow seeds of doubt about the reality of global climate change in the minds of both politicians and the population at large. I can imagine conscious, determined efforts like these, which may have set back a full scale response to climate change by a decade in the US, being classified some day as crimes against humanity, or more correctly, crimes against life on Earth.

**THE GROWING TH**reat to climate stability posed by global warming requires the involvement of an informed public. Otherwise politicians and the corporations that so many of them are friendly with will work to spend enormous sums on measures which won't help slow global warming very much – if at all. Two examples are corn-into-ethanol and oil from coal tar sands both mentioned above.

The scientific consensus on global warming says we have less than ten years to turn things around. This is not a lot of time!

Remember, the Bush Administration has just wasted the first seven years of the new century in denying the reality of climate change – and then funding big business to turn corn into ethanol, which is good for big business profits, but not for averting climate change. If you are not actually changing the amount of energy you use, it is guaranteed that you will be forced by circumstances to make these changes more hurriedly and more drastically, down the road. Be smart about this. In the same way that you plan for the kids going to college, or for your retirement, you need to plan for climate change and how it will affect you. Don't delay. Doing nothing about climate change is not an option.

(9) ONE FAMILY'S CLIMATE CHANGE ACTIONS ARE BOTH IMPORTANT AND A DROP IN THE BUCKET You can do everything you can to reduce what is called your "carbon footprint" – getting a vehicle with much higher mileage, putting solar panels on your roof to generate electricity, buying locally grown food, reducing your air travel and road trips – and still the carbon dioxide in the atmosphere will be increasing. You have to get others involved.

There's no idyllic backwoods to run off to, to get away from the effects of global warming. The issue requires action on a wide range of fronts – personal, family, community, school,

work, local and state and national politics.

Because you can't just sit back in satisfaction, when you've taken some big steps yourself to reduce your carbon footprint, and ignore the fact that the rest of your street, or your acquaintance, is still proceeding in blissful ignorance of the changes global warming will bring.

Doing what you can makes a negligible difference until millions of others do the same.

#### (10) CHIZENS AND GOVERNMENTS MUST WORK TOGETHER NOW – TO REDUCE GLOBAL WARMING DOWN THE ROAD !

Whilst it may still take years for the broad public "inertia to change" to lessen, with respect to global warming, there are a number of very important steps that need to be taken right away to avoid a massive waste of time and resources that will worsen climate change.

A combination of informed citizen activism and forward-thinking political action must ensure that new power plants are designed to be as efficient as possible, and





Power plants have a useful lifespan of around 30 years, so we need to design and build them with efficiency in mind, or we'll be stuck with their wasteful consumption of fossil fuels for decades to come. Stable tax policies to support renewable energy are vital to enact as soon as possible.

One shining example of doing the right thing is Los Angeles Unified School District's current project of constructing 130 new schools – and designing them to be green.

Governments around the world are not acting fast enough to reduce greenhouse gas emissions. "Attempts even to slow the rate of increase of carbon emissions have paralyzed world politics for more than a decade," editorialized the LA Times on March 15, 2008.





Face it, in most parts of California they never go away. Denying their existence will not save your animals from the ravages and disease. I am talking about fleas. Just one can drive an allergic animal to self-mutilation; multitudes can cause an animal to die of anemia. This does not just happen in third world countries. It probably is happening in your neighborhood.

There are a multitude of topical flea preventatives, ranging from spot-on products, powders, sprays, to shampoos. Please don't waste we Rose PAGE 13 your money on electronic flea repelling tags and flea collars. Likewise, good intentions and amulets are cruel excuses since the animal is the one that suffers most. People can also get diseases from fleas (remember **bubonic plague, Hanta virus** ?). If you choose to go the holistic route, you may have to use several products and rotate them every three days to weeks, depending on the product. There are several Veterinarians who practice holistic medicine that can give you advice on what and how to use. Prevention is not one-size-fits-all. It needs to be tailored to your environment, animal population, and individual animal needs.

How products are used can make all the difference. It is far better to use a product before an animal is having dermatitis and other flea-related disease. That is why it is called prevention. Block the problems before they get set up and save yourself some money in the long run. Adding some years to your animal's life is a bonus. Refusing to do anything about preventing flea infestation amounts to animal abuse. It is your duty as an owner to be pro-active in the area of animal health care.





### Acts of God

od knows, Acts of God is good. It is a word play, actually, three philosophical discussions on the human condition. If you're looking for fastpaced action and spine-tingling special effects, you'll have to go to the movies. With the usual conventions and suspension of disbelief, the play speaks eloquent but simple truths.

In Greek theatre, man is the play thing of the gods; in Elizabethan theatre, man is between Heaven and Hell. In modern theatre, at a time when we can view Earth from space and destroy the planet, our world view is that of God's.

In the first act, "Oh, God!" appears to facilitate a discussion between a man, woman, and priest and touches upon religious hypocrisy, sex, racism, and abortion. With the notion of the God force within us, Heaven (peace, love, and happiness) is as close as the local taco stand.

The second act finds a playwright attempting to sell his script of "God Knows" (the first act) to a stereotypical producer. God appears, (this time as a waitress) and explains that life is as simple as

the bumper sticker, "Stuff Happens." We have everything we need---why do we make things so complicated ?

In the third act, we become the studio audience at a video-taping of a sit-com pilot adapted from the play, God Knows. A scientist is pulled up from the audience, and he debunks the notion of God by citing right-brain chemicals and Higg's Bossun, which is ironically called God's Particle

The play ends with the voice of God and a warning to the producer: theatre is powerful, and is not to be misused.

My experience last Sunday at the Ojai Art Center was profound. The playwright, Peter Fox, not only wrote the words, but directed the play, which his wife co-produced. The actors and direction were spot on, word perfect, tight and tidy in an intimate, black-box theatre. The words were the star, and the ensemble gave voice to God's eye. Acts of God is good, God knows.
